## 保良局兒童助養計劃 簡介

保良局兒童助養計劃始於 1961 年，目的是令住局兒童得到外界人士的關懷愛護，並推動『和諧家庭、齊來參與』的訊息，讓外界人士更了解本局工作，同時亦為局方籌募經費，進一步拓展兒童及家庭福利服務。

助養兒童與合法領養兒童，兩者完全不同。助養並不構成助養人與局童之間任何法律上的關係。參加兒童助養計劃是一項善舉，並不賦予助養人於領養兒童方面任何權利或優先考慮。

助養人可助養多位兒童或多個家舍，而每位兒童及每個家舍均可接受多於一位助養人之助養。

兒童因家庭問題，得不到家人照顧，局方會因應他們的需要，安排他們入住禮頓道總局的家舍或位於各公共屋邨的兒童之家。每個單位為一家舍，就如一個小家庭，有照顧他們的家長，有同住的兄弟姊妹。本局轄下共有兒童家舍逾 20 個，總局家舍每家照顧 16 至 18 名兒童，局外兒童之家則每家照顧 8 名兒童。

助養形式:

- 助養兒童—助養人可選擇配定或不需配定兒童，兒童由局方編配。助養人若選擇編配兒童，在完成[探訪導向班]後，可安排到保良局探訪該名兒童。
- 贊助家舍---由局方配定家舍，成為『陽光家庭大使』/『陽光企業大使』，大使將獲發感謝狀一份，及可參加由局方安排的活動，與家舍內小朋友共聚。

捐款金額：助養年期最少一年，助養收入將全數用於拓展兒童及家庭福利服務。

- 助養兒童：助養每名兒童每年均一律為港幣 \$1,200
- 贊助家舍：個人贊助每間家舍每年港幣 \$1,200、  
家庭贊助(最多 4 名員)每間家舍每年港幣 \$1,800、  
團體贊助(最多 10 名成員)每間家舍每年港幣 \$5,000。

助養人如因事需停止助養，請提早一個月通知本局助養部，以便辦理停止助養手續，已付之助養費恕不退還。如逾期未收到助養費，本局當書面促請助養人交費，如逾期六個月仍未收到助養費，則作助養人暫停參加助養計劃論。如有特殊情況，保良局有權拒絕接受個別之助養申請。

## **Po Leung Kuk Child Sponsorship Programme**

Po Leung Kuk Child Sponsorship Programme was launched in 1961, aiming to help the Kuk's children experience the concern and love from the community and to promote the message of "Harmonious Family". Through this Sponsorship Programme, the community will get to know the work of Po Leung Kuk better, as well as to generate revenue to provide and enhance services for families and children.

Sponsorship is totally different from legal adoption, and it does not create any legal relationship between the sponsor and his/her sponsored child. Participation in the Sponsorship Programme is purely a benevolent act and the Programme does not give any privilege or priority to a sponsor who may also be interested in adoption.

A sponsor may financially support more than one child or house simultaneously and likewise a child or a house may be supported by more than one sponsor at the same time.

The Kuk takes care of children facing family problems. Those who require residential care would be arranged to live in either the living units at the Kuk's Headquarters or Small Group Homes in public housing estates. Every living unit is called a House. Each house is like a family, in which children are like "brothers" and "sisters" who help one another, and there are "parents" to take care of their needs. The Kuk now has over 20 houses under its residential child care services, with 16 to 18 children each in the Houses at Headquarter, or 8 children per Small Group Home.

### **Types of Sponsorship:**

- Child Sponsorship—Sponsor is allocated with specific child(ren) and visit to the child(ren) can be arranged.
- House Sponsorship—This type of Sponsorship is known as a "Sunny Family Ambassador" / "Sunny Corporation Ambassador" who sponsor House(s). Sponsor will be invited to join the House activities organized by the Kuk and will have opportunities to meet the children.

### **Sponsorship Commitment:**

The minimum term of sponsorship is one year for each child. All revenue generated from the sponsorship programme will be dedicated towards the welfare of children and families.

- Child Sponsorship—HK \$1,200 per annum per child.
- House Sponsorship—Individual Sponsorship: HK\$1,200 per annum per House;  
Family Sponsorship (max. 4 members): HK\$1,800 per annum per House;  
Group Sponsorship (max. 10 members): HK\$5,000 per annum per House.

Should early termination of sponsorship become absolutely necessary, a sponsor is required to give the Kuk one month's notice in advance. However, any paid sponsorship commitment will not be refundable. Where any sponsorship payment is overdue, the Kuk will remind the sponsor in writing. If no payment for sponsorship is received within 6 months, it will be deemed that the sponsor has terminated the Sponsorship Programme. If the circumstances so required, the Kuk may reject an application for participation in the Programme.
